#### **GENERAL OBJECTIVES:**

- 1. To acknowledge the meritorious performance of Punong Barangays who have exemplified utmost dedication in the performance of their sworn duties and responsibilities in the following essential areas of Public Service: Governance, Social Services, Fiscal Management, Security and Disaster and Public Accountability.
- 2. To identify and recognize the exemplary commitment of Local Chief Executives (LCE) of the Province (Governor), City and Municipality (Mayor) in adopting programs/projects and activities that lead to:
  - 2.1 Being champions of Early Childhood Care and Development.
  - 2.2 Going the extra mile in developing and implementing innovative programs to help support DepEd's Basic Education Learning Continuity Plan (BE-LCP).
  - 2.3 Capacity Building and Professional Development of their component Barangays that result to effective and efficient delivery of public services
  - 3. To serve as a benchmarking example for similar LGUs to replicate and demonstrate that good governance is a reality, and moreover, to be featured in the subsequent editions of the Barangay Handbooks as a Barangay Exemplar (Winning Ways).











#### **ABOUT THE LOGO**



At the heart of the logo is a person reaching for the stars, depicted in a victorious pose. This represents the Filipino lifelong learner, aiming to be the best version of himself.

The three stars also represent the Philippines' three main island groups.

The four-pillared structure symbolizes the strength, permanence, and authority of government institutions that champion the learners' dream and guide it towards fruition.

The laurel leaves emblazoned on the top facade symbolize the excellence and achievement of these institutions that the Gawad recognizes and celebrates with pride.

The circle on which the Gawad title is written signifies the wholeness and complementarity of efforts by all duty-bearers. It also captures the holistic perspective on learning and development that the Gawad zealously champions.

Finally, the logo is rendered in the illustrious colors of the Philippine flag: blue, red, white and yellow, embodying the spirit of nationalism and the Filipino people.











#### Framework of the Review/Assessment, Selection, and Awarding Process

#### PRE - SELECTION STAGE

**CLGPD** (Secretariat)

- Coordinates with DILG National / Regional Offices / Provincial Offices to recommend exemplary Barangays
- 2. Coordinates with Provincial and National Association of Barangay Captains of their endorsement of the exemplaryBarangay.
- 3. Documentations of Projects / Activity of the recommended Barangay for the grant of Recognition / Awarding as Husay Barangay

#### **SELECTION STAGE**

**CLGPD - Selection Committee** 

- Convene the Awards Evaluation Committee to evaluate the credentials of the Project/Activity.
- To determine if such Barangay Project / Activity meets the criteria of being a Husay Barangay
- 3. To recommend the Executive Committee the granting of the Husay Barangay Awards and the Executive Categories.

#### **AWARDING / RECOGNITION STAGE**

#### **EXECUTIVE COMMITTEE**



- 1. Accepts and Assess the recommendations of the Selection Committee of the Husay Barangay and Executives Capacity Development
- 2. Approves grant of Recognition and Award to qualified Executive based on Adopted Criteria.
- 3. Sets the Awarding Date and Venue.













### There shall be a total of twenty-one (21) awards and awardees to be given recognition in an Awarding Ceremony:

- 1. **For the Husay Barangay Awards** Five (5) Punong Barangays for each category of local governance.
- 2. **For the Gawad Edukampyon for Capacity Development -**One (1) for the provincial, one (1) for highly-urbanized city and one (1) for the component city/municipality.
- 3. **For the ECCD-Edukampyon Award** One (1) for the provincial, one (1) for highly-urbanized city and one (1) for the component city/municipality. (x3)
- 3. For the Gawad Edukampyon for Learning Continuity Education one (1) LGU in NCR, one (1) LGU in Luzon, one (1) LGU in Visayas and one (1) LGU in Mindanao











#### Nominations may originate from any of the following:

- 1. Concerned Departments, Agencies, Councils and instrumentalities of Government which are directly involved in the various aspects of local governance.
- 2. Regional/Provincial or Field offices of the Department of the Interior and Local Government (DILG);
- 3. National or Provincial Chapters of various Leagues of Local Government Units as provided in RA 7160;
- 4. LCEs of various Local Government Units:
- 5. Respective Representatives to National Legislature (Congressman)
- 6. Recognized private associations and organizations directly involved and engaged in local governance.











#### TIMELINE OF ACTIVITIES:

- 1. December 6, 2021 Formal launching of 1<sup>st</sup> GAWAD EDUKAMPYON FOR LOCAL GOVERNANCE
- 2. December 7, 2021 to February 28, 2022

Information Dissemination and Solicitation of Nominations Acceptance, Evaluation, and Documentation Period

- 3. Selection Period 1st week of March 2021
- 4. Awarding Ceremony 4th Week of March 2021
- 5. June 2022 Launching of the **2nd** GAWAD EDUKAMPYON FOR LOCAL GOVERNANCE
